## What does ICR Partners, LLC do with your Personal Information?

### —Why?

How does ICR Partners, LLC collect my personal information?	<p>We collect your personal information, for example, when you:</p> <ul style="list-style-type: none"> <li>– Enter into an investment advisory contract</li> <li>– Seek financial advice</li> <li>– Make deposits or withdrawals from your brokerage account</li> <li>– Make a wire transfer or cash movement</li> </ul>
Why can't I limit all sharing?	<p>Federal law gives you the right to limit only:</p> <ul style="list-style-type: none"> <li>– Sharing for everyday business purposes – information about your creditworthiness</li> <li>– Business partners from using your information to market to you</li> <li>– Sharing for non-affiliates to market to you</li> <li>– State laws and individual companies may give you additional rights to limit sharing</li> </ul>

## Definitions

Affiliates	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>– ICR Partners has no affiliates</li> </ul>
Non-affiliates	<p>Companies not related by common ownership or control; they can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>– ICR Partners does not share with non-affiliates for marketing purposes.</li> </ul>
Joint Marketing	<p>A formal agreement between non-affiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> <li>– ICR Partners does not currently jointly market.</li> </ul>
